**FACTORIES & BOILERS INSPECTION DEPARTMENT
NOTIFICATION**

Jaipur, June 24, 2015

S.O. 67 .- In exercise of the powers conferred by sub-section (1) of section 85 of the Factories Act, 1948 (Central Act 63 of 1948) as amended by the Factories (Rajasthan Amendment) Act, 2014 (Act No. 20 of 2014) and in supersession of all previous notifications issued in this behalf, the State Government hereby declares that all the provisions of the said Act shall apply to all places in Rajasthan where the manufacturing process as specified in column number 2 of table given below is being carried on with or without the aid of power or is so ordinarily carried on notwithstanding that,-

- (i) the number of persons employed therein is less than twenty, if working with the aid of power and less than forty if working without the aid of power; or
- (ii) the persons working therein are not employed by the owner thereof but are working with the permission of, or under agreement with, such owner:

Provided that the manufacturing process is not being carried on by the owner only with the aid of his family.

1.	Where the process of Cotton Ginning is carried on.
2.	Where a saw machine and other wood working machine is used.

3.	(i) Where the process of manufacturing of chemicals and process incidental thereto as covered under Schedule-X (except manipulation) prescribed under rule 100 of the Rajasthan Factories Rules, 1951 is carried on. (ii) Where ammonia, chlorine and other toxic gases are used in the process.
4.	Handling and processing of Asbestos, manufacture of any articles of asbestos, and any other process of manufacture or otherwise in which asbestos is used in any form.
5.	All places where crushing and grinding of quartz is carried on.
6.	All places where kier is used in the process of fabrics or yarn washing.
7.	All places having a licensed capacity from Petroleum and Explosives Safety Organisation, Government of India for 10 tonnes or more for LPG (Liquefied Petroleum Gas) and carrying on the following activities:- (i) Bottling of LPG, or (ii) LPG is used in the manufacturing process.
8.	Industrial activity or isolated storage as defined in clause (b) and clause (c) respectively of rule 2 of Rajasthan Control of Industrial Major Accident Hazard Rules, 1991.
9.	(i) Where the process of Manipulation of Stone or any other material containing free Silica as covered under Schedule-XVI prescribed under Rule 100 of the Rajasthan Factories Rules, 1951 is carried on. (ii) Where the process of making of handicraft items of sandstone by dry grinding is carried on.
10.	All places where hazardous process as specified in the First Schedule framed under clause (cb) of section 2 of the Act, is carried on.
11.	All places where the process of twisting of Aluminium conductor reinforced cable/wire or manufacturing of steel wire rope is carried on.
12.	Where the process of steel rolling or re-rolling is carried on.
