G.S.R. 99.- Whereas in exercise of the powers conferred by clause (d) of sub-section (1) of section 29 of the Indian Boilers Act, 1923 (Central Act No. 5 of 1923), the State Government made the Rajasthan Boiler Attendants' Rules, 1954,

And whereas the section 29 of the said Act was amended by the Indian Boilers (Amendment) Act, 2007 (Central Act No. 49 of 2007) and clause (d) of sub-section (1) of section 29 of the said Act was omitted, which empower the State Government to make rules pertaining to the matter relating to the Boiler Attendants and clause (f) was inserted in sub-section (1A) of section 28A of the said Act, which empowers the Central Government to make rules regarding the Boiler Attendants;

And whereas the Central Government has made Boiler Attendants' Rules, 2011 under clause (f) of sub-section (1A) of section 28A of the said Act; and

Now, therefore the State Government hereby makes the following rules to repeal the Rajasthan Boiler Operation Engineers' Rules, 1954, namely:-

- Short title and commencement.- (1) These rules may be called the Rajasthan Boiler Attendants' (Repeal) Rules, 2015.
 It shall come into force with immediate effect.
- **2. Repeal.-** The Rajasthan Boiler Attendants' Rules, 1954 is hereby repealed.
- 3. Saving.- The repeal made under rule 2 of these rules shall not affect,-
 - (a) the previous operation of the rules, so repealed, or anything duly done or suffered there under; or

- (b) any obligation or liability accrued or incurred under the rules, so repealed; or
- (c) any penalty, forfeiture of punishment incurred in respect of any offence committed under the rules, so repealed; or
- (d) any investigation, legal proceeding or remedy in respect of any such obligation, liability, penalty, forfeiture or punishment as aforesaid, and any such legal proceeding or remedy may be instituted, continued or enforced, and any such penalty, forfeiture or punishment may be imposed as if this order had not been made.
