In supersession of order No.F.1(55)L&E/78 dated 5.5.83 the norms for the officers of Factories and Boilers Inspection Department are fixed as under:-

D. Chief Inspector of Factories & Boilers.

To renew the licence of the registered Factories 5-6-96 covered in their area.

- 2. Atleast 45 Inspections of Factories/Boilers in a difference of the countries of the coun
- 3. All non-hazardous factories having licence for momentum 20 but up to 100 workers are to be inspected once in a year.
- 4. All non-hazardous factories having morethan 100 workers are to be inspected ence in 8 months.
- 5. MAH factories are to be inspected once in 4 month.
- 6. Hazardous factories covered under section 2(cb) other than defined in para (5) above are to be inspected once in six months.
- 7. No factories which is required to be inspected by him should remain unrenwed for the current financial year.
- 8. Organising of atleast one course/seminar on industrial safety in a year.
- All non hazardous factories should be inspected with the prior permission of controlling, officer.
- 10. No factory should be allowed to run unregistered for the whole jurisdiction.
- 11. Any other work assigned by the Head of the Deptt.

SENIOR INSPECTOR OF FACTORIES AND BOILERS

- 1. Atleast 45 inspections of factories/Boilers to be parried out inaquarter.
- 2. All non hazardous factories covered under section 85 are to be inspected once in three years.
- All non hazardous factories having licence for morethan 9 workers but up to 20 workers are to be inspected once in 18 months.
- 4. All non hazardous factories having licence for morethan 20 but up to 100 workers are to be inspected once in a year.
- 5. All non hazardous factories having morethan 100 workers are to be inspected once in 8 months.
- 6. MAH factories are to be inspected once in 4 months.

7. Mazardous factories covered under section 2(cb). other than defined in para (6) above are to be inspected once in six months. No factories which is required to be inspected by him should remain unrenewed at the end of the The same of the sa financial year. Organising of atleast one course/seminar on industrial safety in a year. 10. All non hazardous factories should be inspected. only with the prior permission of controlling officer 11. No factory should be allowed to run unregistered for the whole jurisdiction. 12. Any other work assigned by the Head of the Department.

Inspector of Factories And Boilers.

- Atleast 15 inspections of factories/boilers should be carried out in a month.
- All non hazardous factories covered and 85 are to be inspected once in three years.
- 3. All non hazardous factories having licence for morethan 9 workers but upto 20 workers are to be inspected once in 18 months.
- All non hazardous factories having licence for morethan 20 but up to 100 workers are to be inspected once in a year.
- All non hazardous factories having more than 100 workers are to be inspected once in 8 months.
- 6. MAH factories are to be inspected once in 4 months.
- Hazardous factories covered under section 2(cb) Hazardous factories covered under some to be other than defined in para (6) above are to be inspected once in six month.
- No factory which is required to be inspected by him should remain un-renewed at the end of the financial year.
- All non hazardous factories should be inspected only 9. with the prior permission of direct controlling officer.
- 10. No factory should be allowed to run un-registered for whole jurisdiction.
- 11. Any other work assigned by the Head of the Deptt.

If the work load in the area of any officer is less than the minimum required as above, he will intimate the Chief Inspector of Factories & Boilers at the begining of the year and chief Inspector may reduce the norms accordingly.
