## FACTORIES & BOILERS INSPECTION DEPARTMENT NOTIFICATION

Jaipur, October 10, 2016

G.S.R.68 .-Whereas the draft of the Rajasthan Factories (Second Draft Amendment) Rules, 2016 were published as required under section 115 of the Factories Act 1948 (Central Act No. 63 of 1948) vide notification of the Factories & Boilers Inspection Department, No. F-3(1) legal/F&B/2015/799 dated 12-07-2016, in the Rajasthan Gazette, Extraordinary, Part-3(kha), inviting objections and suggestions from all persons likely to be affected thereby, before expiry of the period of forty five days from the date on which copies of the Gazette containing the said notification were made available to the public.

And whereas, copies of the Gazette in which the said notification was published were made available to the public on the 23-07-2016.

And whereas, no objections or suggestions were received on the said Draft Rules.

Now, therefore, in exercise of the powers conferred by section 112 of the Factories Act, 1948 (Central Act No. 63 of 1948), the State Government hereby makes the following rules further to amend the Rajasthan Factories Rules, 1951, namely:-

- 1. Short title and commencement. (1) These rules may be called the Rajasthan Factories (Second Amendment) Rules, 2016.
  - (2) They shall come into force on and from the date of their final publication in the Official Gazette.

- 2. **Substitution of rule 105.-** The existing rule 105 of the Rajasthan Factories Rules, 1951, hereinafter referred to as the said rules, shall be substituted by the following, namely:-
- "105. **Returns.-** (1) The manager of every factory shall furnish online annual return in FORM No. 23 to the Inspector or any other officer appointed by the State Government in this behalf:

Provided that it shall not be necessary for a Manager of Factory to furnish the return in FORM No. 23, if he shall furnish an annual return in Form I appended to the Labour Laws (Exemption From Furnishing Returns and Maintaining Registers by certain Establishments) Amendment Act, 2014 (Central Act No. 33 of 2014).

- (2) The annual return in FORM No. 23 of Form No. 1, as the case may be, shall be submitted on or before 31<sup>st</sup> January of each year."
- 3. **Deletion of FORM No. 24.-** The existing FORM No. 24 appended to the said rules shall be deleted .-
