- S.O. 26 In exercise of the powers conferred by subsection (1) of section 85 of the Factories Act, 1948 (Central Act 63 of 1948), as amended by the Factories (Rajasthan Amendment) Act, 2014 (Act No. 20 of 2014), the State Government hereby, in addition to the places declared by the notification number F3(1)legal/F&B/2015/713 dated 24-06-2015 published in Rajasthan Rajpatra part 4(ga) sub part (II) dated 29-06-2015, declares that all the provisions of the said Act shall apply to all places in Rajasthan as specified in column number 2 of table given below notwithstanding that,-
 - (i) the number of persons employed therein is less than twenty, if working with the aid of power and less than forty if working without the aid of power; or
 - (ii) the persons working therein are not employed by the owner thereof but are working with the permission of, or under agreement with, such owner:

Provided that the manufacturing process is not being carried on by the owner only with the aid of his family.
